**Instructions to Team Representatives, Coaches and Participants**

The objective of the Last Chance Meet is to conduct a post season swimming event that provides another chance for swimmers to achieve their Reserve or Champ time.

- Location:** Galena Park ISD Natatorium  
15027 Wallisville Rd. Houston, Tx. 77015
- Pool:** Indoor / 8 lanes / 25 yards / Non-turbulent lane ropes
- Warm-up:** Pool will be open for warm-ups from 5:00 until 6:20 p.m.
- Start Time:** 6:30 p.m.
- Rules:** In accordance with Clear Creek Swimming League, Inc. 2008 Handbook of Swimming
- Eligibility:** The Last Chance Meet is open to all swimmers listed on their team's Master Roster as of June 18, 2008 and who have competed in a minimum of two (2) CCSL sanctioned swim meets (only one of which may have been a mini-meet). Swimmers should be within 3 seconds of achieving their Champ or Reserve time. Times from the Last Chance Meet may be used as seed times for the Championship Meet Series, but participation in the Last Chance Meet does not count towards the minimum sanctioned meet requirement.
- Entry Information:** On-time entries shall be prepared by each team using Easy Team. Entries shall be exported and saved as an SD3 file and submitted as an attachment via e-mail to the Clerk of Course no later than 9:00 p.m., Sunday, June 22<sup>nd</sup>.
- Order of Events:** The Novice/Reserve meet order of events will be used per Clear Creek Swimming League, Inc. 2007 Handbook of Swimming. There will be no relays, and there will be no ribbons awarded for competition. All events will be pre-seeded timed finals.
- Entry Fees/Deadline:** Fees for on-time entries received prior to 9:00 p.m., Sunday, June 22<sup>nd</sup> are \$3.00 per swimmer per event. All entries after this time are considered On-deck entries. Each team will be held liable for entries submitted on-time. Payment is due no later than 5:00 p.m. at the meet prior to competition. Checks should be made payable to North Channel Aquatics. Please understand we cannot (and will not) make exceptions to this policy.
- On-deck entries can be submitted at the registration table between 4:00-5:15 p.m. prior to competition Monday, June 23<sup>rd</sup>. Entries will not be accepted after 5:15 p.m. On-deck entry fees are \$5.00 per swimmer per event. All On-deck entries shall be paid in full at the time of entry.

- Scratches and Protests:** Scratches shall be submitted to the Clerk of Course no later than 5:15 p.m. prior to competition Monday, June 23<sup>rd</sup>. Any and all protests concerning swimming technicalities (official's decisions) will be handled in accordance with the 2008 Clear Creek Swimming League Handbook.
- Meet Results:** Copies of the complete meet results will be provided to all teams via email to the team league representatives. In addition, meet management reserves the right to post results on the CCSL website as soon as practical. Entry in the meet represents competitor authorization for said posting.
